OUR PROGRAMS

Adult Care Facility Project

assists residents of adult care facilities in matters related to finances, facility conditions, and treatment of residents.

Child Support Defense Project

represents non-custodial parents in child support downward modifications and add-ons for arrears (Suffolk County only).

Community Legal Help Project

partnership of legal services providers to provide legal information, referrals, and limited-scope representation to Nassau and Suffolk County residents at public libraries or community centers.

Consumer Debt Legal Project

helps people with consumer debt legal issues, e.g. medical & credit card debt.

Disability Advocacy Project

assists with appealing Supplemental Security Income (SSI) and Social Security Disability (SSD) application denials.

Domestic Violence Project

helps Suffolk County survivors of domestic violence in family law matters, including obtaining orders of protection and custody.



Education Debt Consumer Assistance Program

provides legal assistance to people who are experiencing student debt problems, including unpaid tuition bills, collection actions, and managing federal and private student loans.

Education and Disability Rights Project

provides legal assistance to students with disabilities and adults with developmental disabilities who are seeking eligibility and services from the Office for People with Developmental Disabilities (OPWDD).

Foreclosure Prevention Unit

works with homeowners to avoid foreclosure and preserve their homes.

Human Rights Project

helps people reintegrate into the community after facing criminal charges by helping them to address criminal history-related civil legal issues. In addition, the project assists transgender, non-conforming, non-binary low-income people overcome the hurdle or name/sex designation changes, housing and employment discrimination, or denial of benefits.

OUR PROGRAMS (Continued)



HIV/AIDS Project

assists people living with HIV and their families on issues affecting public benefits, housing and health care, and with planning for the future through wills, guardianships and advance directives.

Independent Consumer Advocacy Network (ICAN)

provides education, information, and advocacy for participants and caregivers in Medicaid managed care and Medicare long-term care programs.

Legal Support Center for Advocates

serves as a legal center for advocates from social service agencies, religious organizations, health care facilities, and other community-based agencies.

Mental Health Law Project

provides legal assistance in civil matters to persons who are severely and persistently mentally ill. This project focuses primarily on issues such as housing, public benefits, health care, and child support.

Public Benefits Unit

supports the integrity, safety, and well-being of low-income families by maintaining economic stability.

Senior Citizen Law Project

provides legal representation, advice, and referrals to residents of Nassau County aged 60+ in matters relating to health care, housing, Social Security, and future planning.

Social Work Unit

helps our most vulnerable clients complete tasks necessary for successful outcomes to their legal cases and address social issues that may be impeding the resolution of their legal issues.

Tenant's Rights Project

helps tenants with housing issues, including eviction proceedings and federal rent subsidy issues.

Veterans' Rights Project

helps veterans with obtaining veterans' benefits, discharge upgrades, public benefits, landlord/tenant, and family law matters.

Volunteer Lawyers' Project/ Suffolk Pro Bono Project

recruits private attorneys to represent people with low incomes without charge. Our volunteer attorneys handle cases ranging from bankruptcies and guardianships, matrimonial matters and wills.

In 2021, Elmer Dockery was sent an offer by his mortgage company to modify his loan. He received it after the deadline passed and the company did not uphold the opportunity. Dockery was then assisted by NSLS Foreclosure Unit Staff Attorney Christopher Santoro on his foreclosure and wanted to seek modification again to get back on track with his loan.

The mortgage company once again denied him and referenced the 2021 offer despite his inability to accept it because he received it after the deadline. Attorney Santoro raised a lack of good faith, and the court granted a hearing on June 7, 2024.

The bank quickly changed its stance once Attorney Santoro made his opening statement; Dockery was offered a loan modification with a waiver of late fees and legal fees. The hearing was discontinued after the settlement was made. Through Attorney Santoro's successful advocacy, Dockery was finally able to enter into a loan modification agreement after being denied for many years.

In expressing his gratitude towards Attorney Santoro, Mr. Dockery exclaimed "Mr. Santoro helped my mortgage problem by [obtaining] a modification in court which I [have] been fighting for three years."

Also assisting the client was Naldine Philistin from Community Development of Long Island (CDLI), who exclaimed, "Wow!!!! I'm so happy to hear that the parties reached a mutually favorable agreement. Putting a star next to this file too***** Your advocacy is beyond words. Thank you so much for your assistance on this file. Again, this outcome could not have been achieved without your expertise and assistance."

"I am a retired pharmacist who struggles to manage several chronic conditions. I worked full-time at CVS for 10 years until I left in 2017, where I was determined to be permanently disabled and was granted Social Security at the age of 51. "My dad has been an enrollee of VNS (Visiting Nursing Services of New York) since September 2022. He is 89 years old and suffers from Parkinson's dementia, which is a degenerative disease. In other words, he won't improve and will require more care. His steady decline made it necessary to ask for assessments to gain more care hours from VNS. But upon submission of letters from the doctor stating that he required assistance 24 hours a day to prevent "death," plus medical notes from his office visits, VNS continued to deny increased hours, even after appeals were submitted. We decided to request an external appeal. It is a daunting task, but thank goodness we were referred to ICAN. I submitted every form, doctors' notes and night time logs, as requested, to the agency. The assisting attorney, Amanda Davis, used this information to prove my dad's needs for a split 24 hour shift, as requested by his primary care doctor and neurologist, and get him the care he needed. It is such a relief that his needs will finally be met and he will be safe and able to live in his own environment, at home, where he belongs. We would never have been able to approach by ourselves and we are ever grateful for all of the assistance."

COLLABORATIONS



Tenant's Rights Project and Statewide Collaboration

NSLS is working with the Empire Justice Center to provide eviction prevention services to all of Long Island. We are working together to provide legal representation and conduct trainings. We are also working with legal services organizations across all of New York to create a statewide coordinated intake portal for organizations outside of New York City to ensure that anyone who needs service is connected to the correct organization in their region.

Human Rights Project Collaboration

NSLS's Human Rights Project (HRP) works with organizations on state and local levels to advocate for the people of Long Island. We are part of the Coalition of Re-Entry Advocates (CORA) which works to coordinate Re-Entry advocates across the state and provide education and training to the community. We are also part of the Nassau County Re-Entry Taskforce which is run by the Leadership Training Institute (LTI). LTI works with our client base to help provide education and job training programs. We receive referrals from both programs.

Community Legal Help Project Collaborations

NSLS' Community Legal Help Project (CLHP) partners with Touro Law Center's clinics to have professors and law students providing legal information at the local Suffolk County libraries regarding immigration, bankruptcy, and elder law. In 2023, CLHP partnered with CARECEN to provide much-needed legal advice to our immigrant communities. In addition, we partnered with multiple Suffolk County libraries including Brentwood Public Library, Middle Country Public Library (Centereach), Half Hollow Hills Public Library (Dix Hills), and Patchogue-Medford Library (Patchogue) to provide space to meet with clients and additional outreach for the program.

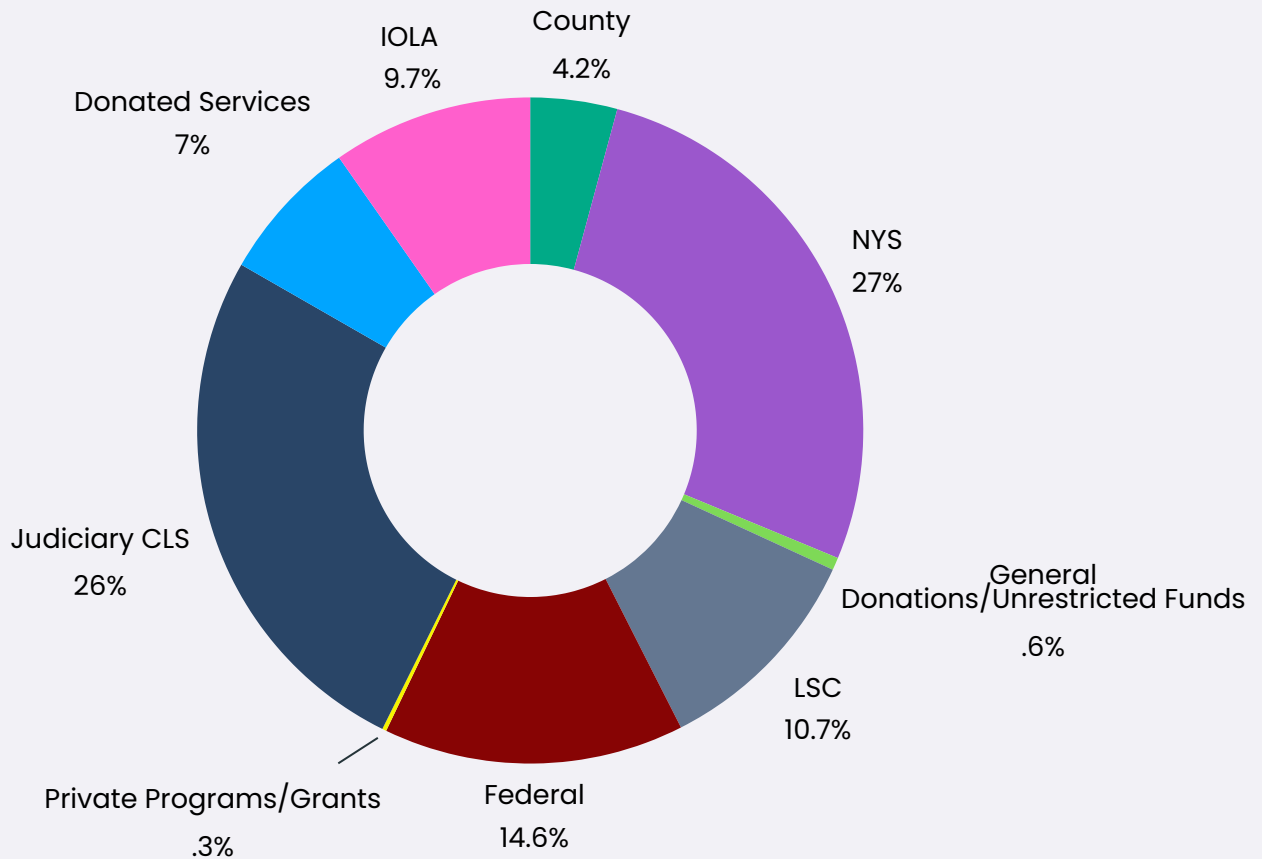
