# **MAY ADVOCACY TIPS**

#### **Unemployment Benefits See Future Increase**

Since 2020, the maximum benefit amount that an individual could receive when collecting Unemployment Insurance has been frozen at \$504. With the recent passage of New York's 2026 budget, the maximum benefit rate will

increase to \$869 starting October 2025. If you or a client needs to make an unemployment insurance appeal or is facing an overpayment, please call our Public Benefits Unit to see if you are eligible for help.

LSLI's Public Benefits Unit provides legal assistance to persons who experience problems with public benefits programs that are administered by the local Departments of Social Services, including:

- Welfare (TANF and Safety Net)
- Medicaid
- Food Stamps (SNAP)
- Child Care Assistance
- HEAP
- Emergency shelter for the homeless
- Unemployment insurance appeals and overpayments
- Other emergency assistance programs

We also assist low-income households in establishing Supplemental Needs Trusts to eliminate the Medicaid spend-down and assist homeless families in obtaining rent supplements from DSS to enable families to leave the shelters or retain permanent housing. #### Beware of Student Loan Scams

Student Loan scams are on the rise. You may be getting emails about your federal student loans. Sometimes scammers will even use government seals or logos. Don't rely on that for legitimacy. You should never need to pay an

upfront fee to receive guidance on your student loans. You should not be sharing your FSA





ID, and do not rely on promises of special access. If you are unclear about the status of your student loans, start by logging in to <u>studentaid.gov</u>. From there, you can find information on your loan services and how to reach them. If your loans are private, go straight to your loan services for help. If you need help navigating your federal or private student loans, please contact our Education Debt Consumer Assistance Program to be evaluated for free services at (516) 292-8100.

LSLI's Education Debt Consumer Assistance Program (EDCAP) provides legal assistance to people who are experiencing student debt problems, including unpaid tuition bills, collection actions, and managing federal and private student loans. Assistance is available to student borrowers, parents, and other family members regardless of income. # Long Island Nissan Dealerships Required to Reimburse Customers it Overcharged

Garden City Nissan, Huntington Nissan, Legal Nissan in Syosset, and Smithtown Nissan will be reimbursing customers who were overcharged and

given inaccurate receipts for end-of-lease buyouts after the onset of the COVID-10 pandemic. The dealerships have also agreed to reform their invoicing practices to ensure all lease buyout customers are neither overcharged nor provided with inaccurate receipts. LSLI's Consumer Debt Legal Assistance Project provides legal assistance to persons who are experiencing consumer debt problems, especially in matters of medical and credit card debt. Services may include litigation defense and representation, phone advice, and/or referral for further services, including bankruptcy, where appropriate. #### **Reverse Mortgage Loans**

A reverse mortgage is a type of mortgage loan that is generally available to homeowners 60 years of age or older that permits you to convert some of the equity in your home into cash while you retain ownership. This can be an attractive option for senior citizens who may find themselves "house rich" but

"cash poor," but it is not right for everyone. Reverse mortgages are "non-recourse" loans, which means that if you default on the loan, or if the loan cannot otherwise be repaid, the lender cannot look to your other assets (or your estate's assets) to meet the outstanding balance on your loan. No payments are due on a reverse mortgage until some trigger event, such as moving out of the home or death of the borrower. Please consult a lawyer, financial advisor or housing counselor before you make any decisions. LSLI's Foreclosure Prevention Project provides free legal services to homeowners hoping to prevent foreclosure of their homes. Services provided include:

- Legal representation at the various stages of the foreclosure process, including at mandatory court settlement conferences, drafting pleadings, and drafting and opposing motions
- Assist borrowers pursuing loss mitigation options, including loan modifications
- Advice and Counsel

The Project is part of the HOPP network, a Statewide coalition that includes HUD-certified housing counseling agencies. As such, we will make referrals to and collaborate with HOPP funded, non-profit housing counseling agencies. Clients must reside in the homes subject to foreclosure and have low to moderate-income for Long Island, as annually set by HUD. Please call the office closest to you to see if you are eligible for legal services. Interpreters are available. #### Housing Insecurity Prevention Assistance Programs Open



Nassau County Down Payment Assistance Program Open Until June 18th, 2025. The Nassau County HOME Down Payment Assistance Program will provide eligible first-time homebuyers with up to \$50,000 towards down payment/closing costs towards the purchase of an eligible new or existing

single-family home, provided that the applicant is income-eligible and meets all program requirements. For more information and to apply, <u>please visit Long Island Housing</u> <u>Partnership's website.</u>

**Town of Babylon**'s Tenant-Based Rental Assistance Program opened on December 18th, 2023. This program is for extremely low-income households who are in rental arrears to help residents regain housing stability and prevent homelessness. For more information and to apply, <u>please visit Long Island Housing Partnership's website</u>.

**Town of Babylon's** Mortgage Arrears Program opened on February 27th, 2024. The Town of Babylon (Town) is making CDBG-CV funds available for low to moderate-income Town of Babylon residents with mortgage arrears incurred due to a COVID-19-related loss of income. Funds will cover a maximum of 6 consecutive months of arrears, subject to a cap of \$50,000, and are paid directly to the lender. **Town of Brookhaven's** HOME Down Payment Assistance Program will provide eligible firsttime homebuyers with up to \$50,000 towards down payment/closing costs towards the purchase of an eligible new or existing single-family home, provided that the applicant is income eligible and meets all program requirements. The applicant must also be able to satisfy the mortgage lender's minimum down payment requirements and be able to secure a mortgage. Homeowners are required to reside in the home as their principle residence for a minimum of 10 years or HUD will require a full repayment of the HOME down payment assistance provided. Applications are being accepted on a first-come, first-served basis until funding has been exhausted. Tip: If you are a tenant and the property you currently live in is being foreclosed upon and the foreclosure is pending, continue to pay your rent. Before ownership is transferred to a new owner, tenants remain subject to the requirements of their lease agreements, including payment of rent to the landlord. In some cases, a receiver may be appointed to manage rental payments while the action is pending. If a receiver is appointed, tenants should receive proof of appointment and information on how to submit rental payments to the receiver instead of to the landlord. During the pending action, the landlord is required to maintain the property as they would in the absence of any foreclosure action.

Legal Services of Long Island, in partnership with Empire Justice Center, can now assist Nassau and Suffolk residential tenants with housing-related legal problems (like eviction) and a household income of up to 80% of the Area Median Income. Services are available through this partnership regardless of immigration status. Please call the office closest to you to see if you are eligible for legal services. Interpreters are available. Suffolk residents west of 112 can call 631-232-2400 and east of 112 can call 631-369-1112. Nassau residents can call 516-292-8100.



#### Community Legal Help Project






